SCHOOL BOARD ELECTIONS
(Boundaries of Director Districts)

Director District A

Beginning at the northwest corner of Section 6 in Township 36 North, Range 4 East of the New Mexico Meridian in Conejos County, Colorado;
Thence south 12 miles to the southwest corner of Section 31 in Township 35 North, Range 4 East of the New Mexico Meridian;
Thence east to the southeast corner of Section 36 in Township 35 North, Range 6 East of the New Mexico Meridian;
Thence north approximately four miles to the northeast corner of Section 13 in said township and range;
Thence east approximately 16 1/2 miles to the point of intersection of the south line of Section 11 in Township 35 North, Range 9 east of the New Mexico Meridian with the west boundary of U.S. Highway 285;
Thence northeasterly along the west boundary of U.S. Highway 285 to the point of intersection with the north line of said School District RE 1-J;
Thence west approximately 3 1/2 miles to the northwest corner of Section 10 in Township 36 North, Range 9 East of the New Mexico Meridian in Alamosa County, Colorado;
Thence south to the northwest corner of Section 27 in Township 36 North, Range 9 East of the New Mexico Meridian in Conejos County, Colorado;
Thence west to the northwest corner of Section 29 in said township and range;
Thence south along the west line of said Section 29 to the west quarter corner;
Thence west five miles to the west quarter corner of Section 28 in Township 36 North, Range 8 East of the New Mexico Meridian;
Thence north 4 1/2 miles to the northeast corner of Section 5 in said township and range;
Thence west to the point of beginning.

Director District B

Beginning at the northwest corner of Section 18 in Township 35 North, Range 7 East of the New Mexico Meridian in Conejos County, Colorado;
Thence south four miles to the southwest corner of Section 31 in said township and range;
Thence east to the southeast corner of Section 31 in Township 35 North, Range 9 East of the New Mexico Meridian;
Thence north to the northeast corner of said Section 31 in said township and range;
Thence east to the west line of U.S. Highway 285;
Thence northeasterly along said west line of U.S. Highway 285 to the south line of Section 11 in Township 35 North, Range 9 East of the New Mexico Meridian;
Thence west along the south line of Director District A to the point of beginning.

Director District C

Beginning at the northeast corner of Section 21 in Township 36 North, Range 10 East of the New Mexico Meridian in Conejos County, Colorado;

Thence north two miles to the north line (being the northeast corner) of said School District Re 1-J;

Thence west to the point of intersection with the west boundary line of U.S. Highway 285;

Thence southwesterly along U.S. Highway 285 to the point of intersection with the north line in Section 34 in Township 35 North, Range 9 East of the New Mexico Meridian;

Thence east to the south quarter corner of Section 25 in said township and range;

Thence north and east along the meanderings of the east boundary line of said School District Re 1-J to the point of beginning.

Said Director District C contains all of said district lying north of the north line of Section 34, 35 and the west half of Section 36 in Township 35 North, Range 9 East of the New Mexico Meridian lying east of the west boundary of U.S. 285 in Conejos and Alamosa Counties, Colorado.

Director District D

Beginning at the northwest corner of Section 6 in Township 34 North, Range 7 East of the New Mexico Meridian in Conejos County, Colorado;

Thence south six miles to the southwest corner of Section 31 in said township and range;

Thence east to the southeast corner of Section 35 in Township 34 North, Range 8 East of the New Mexico Meridian;

Thence south and east along the south boundary line of said School District Re 1-J to the point of intersection with the west boundary line of U.S. Highway 285;

Thence northeasterly along the west boundary line of U.S. Highway 285 to the point of intersection with the north line of Section 34 in Township 35 North, Range 9 East of the New Mexico Meridian;

Thence west to the northeast corner of Section 32 in said township and range;

Thence south to the southeast corner of Section 31 in said township and range;

And thence west to the point of beginning.

Also all property within the exterior boundaries of the Town of Romeo, Colorado.

Director District E

Beginning at the point of intersection of the north line of Section 34 in Township 35 North, Range 9 East of the New Mexico Meridian in Conejos County, Colorado, with the west boundary line of U.S. Highway 285;

Thence southwesterly along the west boundary line of U.S. Highway 285 to the north line of the Town of Romeo;

Thence east along the north line of the Town of Romeo to the west line of Section 22 in Township 34 North, Range 9 East of the New Mexico Meridian;
Thence north to the northwest corner of said Section 22;
Thence east to the northeast corner of said Section 22;
Thence south to the north boundary line of Colorado Highway 142;
Thence east along the north boundary line of Colorado Highway 142 to the point of intersection with the east boundary line of Section 24 in Township 34 North, Range 10 East of the New Mexico Meridian;
Thence north to the east quarter corner of Section 12 in said township and range;
Thence west and north along the exterior boundary of said School District Re 1-J to the northeast corner of the northwest quarter of the northwest quarter of Section 35 in Township 35 North, Range 9 East of the New Mexico Meridian;
Thence west to the point of beginning.

Director District F

Beginning at the point of intersection of the north boundary of the Town of Romeo in Conejos County, Colorado, with the west boundary of U.S. Highway 285;
Thence east to the west line of Section 22 in Township 34 North, Range 9 East of the New Mexico Meridian;
Thence north to the northwest corner of said Section 22;
Thence east to the northeast corner of said Section 22;
Thence south to the north boundary line of Colorado Highway 142;
Thence east along the north boundary line of Colorado Highway 142 to the point of intersection with the east line of Section 24 in Township 34 North, Range 10 East of the New Mexico meridian;
Thence south to the southeast corner of Section 36 in said township and range;
Thence west to the southwest corner of Section 32 in said township and range;
Thence south one-half mile;
Thence east three-quarters mile;
Thence north one-half mile;
Thence west three-quarters mile to the north quarter corner of Section 6 in Township 33 North, Range 10 East of the New Mexico Meridian;
Thence south to the center of said Section 6;
Thence west one-half mile;
Thence north to the northwest corner of said Section 6;
Thence west to the south quarter corner of Section 34 in Township 34 North, Range 9 East of the New Mexico Meridian;
Thence south to the center of Section 3 in Township 33 North, Range 9 East of the New Mexico Meridian;
Thence west to the west boundary line of U.S. Highway 285;
Thence north along the said west boundary line of U.S. Highway 285 to the point of beginning.
